It is the responsibility of the user of the material intended to come in contact with foodstuff, to communicate to our company possible restrictions regarding the components (presence of additive and aromas) of the food that must be packed.

The overall migration limits and all the other specific restrictions whose the monomers or/and the additives are subjected to, including metals and primary aromatic amines Annex II of Reg. (UE) No 10/2011, are respected in accordance with the usage conditions above mentioned.

The assertion is supported by analytical proves, carried out in accordance with the Regulation (EU) No 10/2011 or based on calculations carried out considering the content of the substances subjected to migration limits. The computations have been arranged assuming that 1 kg of food comes in contact with 6 dm2 of packaging material.
